### Plenary - The impact of the COVID-19 pandemic on Webcast workplace bullying and harassment in Canada

### Dr. Adriana Berlingieri, Centre for Research & Education on Violence Against Women & Children, Western University

The COVID-19 pandemic and the sudden shift to virtual work have significant implications for how work and workplaces are conceptualized and designed, and for harassment and violence prevention and intervention practices. From 2020-2021, a national study was undertaken, bringing together researchers, labour partners, advocates, and workers from across Canada to learn about workers' experiences of harassment and violence in the workplace. In this presentation, we draw on findings from this study to explore the diverse ways that COVID-19 and transitions to virtual work impacted workers' experiences of harassment and violence, reporting, and workplace supports. We identify implications for workplaces and possible best practices.

### Workshop - Supporting Indigenous peoples and communities when workplace sexual harassment occurs

A question this session will aim to answer is what unique considerations need to be addressed when an Indigenous person is facing workplace sexual harassment? This session will focus on supporting Indigenous folks/communities, cultural competency and how race and colonialism contribute to sexual harassment in the workplace. At PLEA Saskatchewan, we are often asking ourselves how to better engage with Indigenous individuals and communities and it is a goal of ours to increase the usage of our services to Indigenous folks.

## Workshop - The role of pedagogy in supporting clear legal communication

For more than 20 years, Éducaloi has been refining its approach to access to justice. Initially focused on clear legal communication, it has evolved over time. Éducaloi recognized that it is not enough to communicate legal information clearly and concisely. It's also important to reflect on the means and techniques to ensure that the target audience remembers the information, can put it into practice, and that it has a significant impact on their everyday lives. To optimize its activities, Éducaloi added education specialists to its team. Pedagogy is a field of expertise in itself and its practical impacts demonstrate both its necessity and its effectiveness.

The workshop will address the following questions: What is pedagogy? What are its main impacts in terms of access to justice? How do clear legal communication and pedagogy interact? Which pedagogical strategies and techniques can be put into practice most easily by organizations?

## Workshop - Journey to empowerment: supporting newcomers facing sexual harassment

Join Ravneet Riar (she/her) from the Migrant Workers Centre (MWC) for a practical workshop outlining how to carefully and intentionally create a space of safety, inclusivity, and trust for newcomers facing sexual harassment at work. MWC is developing a toolkit and adjoining workshop to provide training to service providers on trauma-informed and culturally-sensitive practices to support newcomers who have experienced sexual harassment. This toolkit is practical and hands-on, simplifying the journey from theory to practice by providing many tangible tips and strategies. During her presentation, Ravneet will present the context and learnings from the process of developing this resource. She will also walk you through some highlights of the toolkit. This workshop will leave you with actionable steps you can take to become more trauma-informed and culturally sensitive in your work with newcomers.

We will conclude with participants receiving a set of questions and tips they can use to begin their own private partnership exploration and some things to keep in mind as they draft their own programs.

# Workshop - Swimming upstream: primary prevention approaches and engagement strategies to help stop workplace sexual harassment

This presentation from the Association of Alberta Sexual Assault Services (AASAS) will offer participants insight into pre/post workplace sexual harassment prevention campaign research and how to use social science to affectively engage people in the issue of workplace sexual harassment. We'll discuss challenges with typical training and awareness approaches to sexual harassment and the new approach we're taking with the #momentsmatter campaign and Engagement Strategies training. We will explore how participants can apply research informed best practices for adult online learning, as well as behavioural sciences and social norms marketing strategies in their own approach around anti-sexual harassment social change initiatives.

## Workshop - Meeting collective legal needs and the role of PLEI: a case study

Ontario's 55,000 nonprofits must update governing documents to comply with Ontario's new Not-for-Profit Corporations Act. A daunting task, as half have no staff and two-thirds have annual revenue under \$100,000. The demand for education and information by nonprofits on issues relating to the new law, and on other legal issues, has been enormous. In recent months, CLEO has delivered workshops and answered enquiries for over 3,000 nonprofits. To meet the demand, CLEO has been experimenting with techniques that can serve to foster peer education among networks, as well as educate organizations and individuals. In this session, you will be introduced to the principles, techniques, and strategies that could support other public legal education and information efforts.

Workshop - Understanding the difference in workplace harassment for workers with disabilities

How does workplace harassment differ for workers with disabilities, and specifically for women workers with disabilities? Bonnie Brayton from DAWN Canada and Maureen Haan from CCRW will unpack the current state of workplace harassment for workers with disabilities, focusing on women with disabilities. The journey of workers with disabilities will be the centre of the workshop, with an understanding of barriers of accessing justice, education and other resources. An understanding of how COVID-19 has affected workers with disabilities in the workplace will be underscored and discussions on promising practices and systemic change recommendations in order to protect the rights of workers with disabilities will be explored.

Those of us who provide public legal education regularly assess whether our PLEI programs are effective. We need to know this so that we can adjust and improve our programs; continuous learning and improvement are part and parcel of our work. But how do we find out if our efforts are effective for the public we're aiming to reach, and whether we're making a difference? In this session, four panelists, each of whom has been involved in evaluating or researching PLEI initiatives, will share their perspectives on these questions.

Workshop - The creation of public legal education material for Indigenous communities

This presentation will review Native Counselling Services of Alberta's 53-year history regarding the development of legal education material for Indigenous communities. An overview will be given of BearPaw Media and Education. The workshop will outline the importance of creating culturally relevant resources through an Indigenous worldview lens. How information is vetted by Indigenous elders will also be discussed. Information will also be provided on what type of resources are produced, as well as, how they are distributed using a trauma-informed approach.

### Workshop - Campaigning against the misuse of nondisclosure agreements (NDAs) in workplace sexual harassment situations and the harm NDAs cause

### Jennifer Khor, Community Legal Assistance Society BC Dr. Julie MacFarlane, University of Windsor

The #MeToo Movement brought attention to sexual harassment and sexual misconduct. It also started a discussion about non-disclosure agreements (NDAs) in settlements that prevent complainants from talking about what happened and the harm this causes. NDAs protect the employer and the harasser by silencing the complainant. Zelda Perkins broke her NDA with the notorious Harvey Weinstein in 2017. Zelda and Julie Macfarlane, Emerita Distinguished Professor of Law at the University of Windsor, have teamed up to found Can't Buy My Silence, to campaign for legislation to ban the misuse of NDAs. CLAS and Can't Buy My Silence have launched a campaign in BC to raise awareness on the misuse of NDAs and advocate for legislative change. Join us to learn why NDAs are a problem and about the global fight to restrict their use. We will share strategies from our campaign, from raising awareness with public legal education, including engaging with media and use of social media, developing allies, and advocacy strategies for legislative reform.
